## Location

The property is situated in a prominent location on the eastern side of Busby Road, Clarkston, Glasgow.

Busby Road sits within Clarkston, a popular residential suburb of Glasgow approximately 4.5 miles to the south of Glasgow City Centre. It forms the main commercial thoroughfare for the area. Nearby occupiers include Westpoint Homes, Bonnie Fleurs and AA Podiatry.



### Description

The property comprises a retail unit over ground floor only and sits within a traditional three storey building of stone construction.

The subjects offer sales over the ground floor with staff facilities to the rear. The unit formerly traded as a beautician and is well presented, benefitting from internal division into four possible treatment areas.

Externally, the unit is secured by way of two wooden 'storm' type doors with a wooden frame glazed panel frontage to the side.

The unit is arranged over ground floor level only and extends to the following approximate net internal floor areas:
