LOCATION

The subject premises are located on Coldstream Place off Keppochhill Road in the Port Dundas area of Glasgow, north of the M8 and close to Glasgow city centre.

The location benefits from excellent transport links with J16 of the M8 situated 0.6 miles away and good public transport links with multiple bus routes operating nearby. The Port Dundas area is predominantly light industrial as well as having some offices, leisure and an increasing amount of new residential development in the area.

Nearby occupiers include Graham's Dairy, Booker Wholesale, Screwfix, Toolstation, Howdens, HSS Hire, and Jewson amongst others.

Description

The property comprises a modern standalone trade counter unit with secure private yard.

The unit is formed of a steel portal frame with blockwork walls (facing brick externally).

The premises are currently configured as a trade counter with shop area to the front accessed via a glazed pedestrian door. Flooring is part tiled and part vinyl with painted walls and lighting throughout.

The unit also benefits from ancillary office accommodation, w/c facilities, and a separate store area with electric roller shutter.

The premises have not yet had electricity supply connected.
